NONPROFIT EXCELLENCE ACADEMY

In 2024, the Community Foundation for Ocala/Marion County launched the "Nonprofit Excellence Academy" through its Nonprofit Resource Center. With the rapid population growth in Marion County and an increasing demand for human services, local nonprofits are estimated to serve over 100,000 residents, a number that continues to rise significantly. Many of these nonprofits are small organizations with budgets under \$150,000. Alarmingly, a recent study by Zippia Research reveals that only 50% of nonprofits possess the tools needed for success, and 30% are projected to close within the next decade.

The Nonprofit Excellence Academy was designed to address these challenges by focusing on leadership and professional development at all organizational levels. It equips nonprofits with the skills and resources needed to thrive, ensuring they can continue meeting the needs of Marion County's growing community.

GRANT SERVICES

Sustainability is the biggest threat to nonprofit organizations, especially those that are small and medium size. Grants can provide long-term, sustainable funding that enables organizations to grow both programming and infrastructure. In 2019, The Community Foundation reached out to the nonprofit community and found that many nonprofit organizations were not applying for grant funding and only 2% had a professional grant writer on staff. For this reason, the Community Foundation of Ocala/Marion County is focused on helping nonprofit organizations with the foundational pieces to build capacity and sustainability through Grant Services.

We offer nonprofits a variety of ways to get started; our grant readiness course, grant research through scans, grant writing & reviews, as well as environmental scans.



THE ROCK PROGRAM

Thanks to the invaluable skills and tools provided during the Foundation's grant readiness workshop, including the Grant Scan, The Rock staff has written and successful secured 7 grants in 2024 totaling \$99,500! This funding made a huge impact. Funds assisted with the launch of The Rolling Rock Truck, visiting 9 community locations like Pace Center for Girls and Phoenix House, and expanded The Rock to more middle and high schools making them more efficient in delivering essential services where they are needed most. Funds also helped expand The Rock's staff and strengthen their mission to serve more youth and communities, laying the foundation for even bigger initiatives in 2025!

FORT KING HERITAGE FOUNDATION

Through the guidance and support of the Foundation's Grants Team and opportunities identified and presented through the Grant Scan, Fort King Heritage Foundation has been awarded \$10,000 to bring history to life at the Festival at Fort King. This two-day event in December 2024 invited the community to step into the 1800s with historic-themed crafts, games, workshops, activities, living historians, vendors, food, drinks, and much more. The highlight of the festival was an engaging reenactment of the event that fueled the start of the Second Seminole War. This festival is a way to preserve history and enrich our local community.



THE CITY OF OCALA

The Community Foundation for Ocala/Marion is proud to partner with the City of Ocala to address key community needs. By working closely with City Departments and utilizing the Grant Scan, funding opportunities were uncovered that align with their vision. These options were evaluated to ensure they are practical and impactful and then submitted applications to secure the necessary resources to turn ideas into action. Projects include partnerships with Community Services to support affordable housing, Parks and Recreation to enhance public spaces, and Ocala Fire and Rescue to secure critical equipment and develop outreach programs. Successes like the \$133,000 formula grant for streetlight upgrades with Ocala Electric, where the Community Foundation provided support in completing the application, highlighting the power of collaboration in action. This partnership continues to demonstrate how working together makes a lasting difference in meeting the needs of Ocala residents.

COMMUNITY INITIATIVES

Below are a few community initiatives the Community Foundation supported in 2024.

A HOME FOR A HERO

The "A Home for a Hero" initiative in Marion County, supported by Pedro R. Interian, founder of Capris Furniture, and his sons, have provided a deserving military veteran with a new home. Partnering with C4 Construction and the Housing Finance Authority of Marion County, the family has donated \$30,000 toward the home's construction in Rainbow Springs. This meaningful project honors veterans' service while encouraging the community to join in supporting those who have sacrificed for their country.









FEEDING THE FEARLESS

At the Community Foundation for Ocala/Marion, we are proud to support initiatives like Feeding the Fearless, a program that embodies the heart of our community. This initiative is dedicated to providing meals to first responders

and frontline workers across Marion County, our firefighters, paramedics, police officers, and healthcare professionals who work tirelessly to keep us safe. What makes this effort truly special is the collaboration behind it. Many of our local nonprofits generously lend their time to help prepare and deliver meals directly to fire stations, hospitals, and emergency facilities. It's a powerful reminder of what we can accomplish together when our community comes together to show gratitude and care for those who give so much to us.

WEST OCALA TOUR

The City of Ocala hosted a tour of West Ocala, inviting Community Foundation board members & selected community leaders to explore the area's needs and uncover opportunities for revitalization. The tour highlighted key challenges such as infrastructure improvements, housing, and access to resources, while also showcasing the neighborhood's rich history, potential, and resilience.





ADAM HANSON YOUTH PHILANTHROPY IN ACTION

Our Adam Hanson Youth Philanthropy in Action (YPIA) program is an educational initiative aimed at teaching middle school students the value of philanthropy and how they can impact their community from a young age. Hosted one day per week for six weeks, the program is facilitated by Community Foundation Staff, with assistance from NonProfit Business Council (NPBC) Steering Committee Steering Committee Members, and local volunteers. It explores the history of philanthropy, the roles of different societal sectors (nonprofit, for-profit, government), and helps students discover their passions and understand community needs. Students, grouped by shared interests, develop "case for support" presentations for local charities, resulting in the allocation of a \$500 donation.

SHARE THE LOVE

Launched in 2020 to support Marion County's frontline workers and first responders during the height of the pandemic, the Share the Love program has grown into a cherished annual tradition. Held the week of Valentine's Day, this heartfelt initiative brings together local businesses, community leaders, and organizations to express gratitude for those who serve our community tirelessly.

Each year, participants visit every Fire Station both City and County, EMS station, 911 Call Center, AdventHealth and HCA Hospitals, The Heart of Florida, and Free-Standing Emergency Room in Marion County. Highlights of the event include thoughtful gestures like Chick-fil-A delivering cookies, ensuring these heroes feel appreciated for their dedication and service.











BACK TO SCHOOL

Since its inception in 2019, the Back to School Community Giveback has played a vital role in preparing over 6,000 students in Marion County for academic success. Founded by The Community Foundation for Ocala/Marion, AdventHealth Ocala, and Marion County Public Schools, the program has distributed more than 30,000 backpacks filled with essential school supplies.

Initially held at a single location, the initiative expanded to nine locations by 2024, significantly increasing its reach to serve diverse communities and cities across the county. This effort has been made possible through the support of major partners, including The Rock, Stuff the Bus, Adam Hanson Better Communities Fund, Panzer Medicine, Team Cone, Ausley Construction, The Boyd Group, Heart of Florida, Gill Logistics, and His Compassion.

Additionally, an inclusive school supply drive launched by The Community Foundation supports over 40 nonprofit organizations, ensuring resources reach a wide range of students. This includes public school students, special needs programs, homeschoolers, foster care programs, homeless students, and those in after-school programs. The Back-to-School Community Giveback continues to grow, demonstrating its lasting impact on Marion County's children and families.

GIVE4MARION

In five years, Give4Marion has grown exponentially, raising over \$3 million in 2024, compared to \$310,000 in its first year. This 33-hour giving event supports Marion County nonprofits, combining online donations, prizes, and donor matches. Starting as a pandemic response, it has become a vital fundraiser,



connecting nonprofits to donors and volunteers. Last year, nonprofits benefited from small contributions amplified through matching opportunities, reflecting the community's growing generosity and support.

Established in 1986 and incorporated into the Community Foundation in 2018, the Estate Planning Council of Marion County connects accountants, attorneys, financial advisors, and other estate planning professionals. With over 40 members, the Council fosters collaboration and professional development through quarterly meetings, social events, and educational resources. Administered by the Community Foundation and guided by a volunteer Executive Board of estate planning experts, the Council offers a platform for networking and sharing best practices.



The NonProfit Business Council (NPBC), founded 13 years ago under the Chamber & Economic Partnership (CEP), transitioned to the management of the Community Foundation in 2016, sparking significant growth. Committed to showcasing the economic contributions of nonprofits, the NPBC focuses on strengthening their leadership, fundraising, board development, staff training, and compliance efforts. It also promotes collaboration and offers philanthropic education. Today, the Council represents a network of 178 nonprofit organizations, guided by a diverse steering committee of sector leaders.

This initiative empowers Marion County to take control of its challenges, bringing people together to create lasting change.
